3. **Para 4 - Term & Conditions Point No. 1** The following sentence is added after the existing sentence:- Ernest Money will also be accepted in the form of Bank Guarantee. Technical Bid will open on date 22.09.2017 at 11.00 AM.
4. **Para 4 - Point No. 8** The following sentence is added after existing sentence:- "Deficiency means repeated recurrence of shortcomings in delivery of service or deployment of staff".
5. **Para 4 - Terms & Conditions Point 11:** Is substituted as under "Money granted by GOI such as untied fund, annual maintenance fund, corpus grant/fund or any such other grant can be utilized by the service provider on activities approved under GOI Guideline". RMRS will be managed by service provider. The income generated through RMRS will be used as per objectives and guidelines of RMRS, MOIC of PHC will be the member secretary of RMRS.
6. **Para 4 - Point No. 18 :** The existing words and figure "one month" is substituted by "45 days".

7. **Para 4 - Point No. 23** : After existing para a sentence is added "The service provider may terminate the agreement after giving three month prior notice to the department".
8. **Para 8 - Performance outcome/ Indicator** : Target of normal delivery / Year- Delivery in institution at least 50% in 1<sup>st</sup> Year, 60% in 2<sup>nd</sup> & 3<sup>rd</sup> Year and after 3<sup>rd</sup> year 70% achievement will be required target of normal delivery and other target is not change.
9. **Para 8 : Performance satisfactory** : 70% achievement of total performance outcomes and indicators will be satisfactory .
10. **Para 10 : Evaluation procedure stage - 2 - Experience** : The existing first sentence is substituted by "Agency having experience of running of Government Hospital/ other community outreach/ Health related project having minimum one doctor and paramedical staff".
