Dear Candidate,

We herewith offer you contractual engagement to carry out the above mentioned assignment as per following details:

1. Consequent upon your selection made by the selection board, you are hereby offered to carry out the assignment of Specialist Doctors (Pédiatrician) at **Choti Sadri, Pratapgarh** on a contract basis for a period of 12 months on a consolidated fee of Rs 40,000/- per month (Rs Forty Thousand only).
2. The terms of your offer are as given in the Terms of Reference (Annex-I) attached to this offer letter.
3. Other conditions of your service under the Society will be governed by such rules as may be adopted by the Society from time to time.
4. You have to sign an agreement with RMRS of concern CHC/SDH/DHS on Rs. 500/- Stamp paper. (Format is attached) Annex-II at the time of your joining under the society.
5. Please note that your offer is also subject to:
 - (a) Production of a certificate of fitness from the Competent Medical Authority viz. Civil Surgeon, District Medical Officer, Medical Officer or equivalent status in the prescribed form enclosed (Annex-III)
 - (b) Production of original certificates: -
 - (c) Photo Proof of identity- (eg driving license/election card/passport)
 - (d) Academic certificate-12th / M.B.B.S / M.S. / M.D.
 - (e) Certificate for proof of age.
 - (f) Character certificate in the prescribed form (Annex-IV) from your present/last employer.
 - (g) Domicile certificate/ Address Proof

6. If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material/information, you will be liable to be removed from the said post under the Society and for such other action as the Society may deem necessary.
7. On acceptance or otherwise of the terms and conditions as mentioned above, you are requested to report for duty along with the required documents latest by 20th November, 2009 to Chief Medical & Health Officer-Pratapgarh.
8. If you fail to join your duties by the above stipulated date, the offer of contractual engagement to you is liable to be treated as cancelled forthwith.
