INVITATIONS FOR BIDS (IFB) **NATIONAL COMPETITIVE BIDDING**

1. The Government of India has received a credit from the International Development Association for reconstruction and development toward the cost of RAJASTHAN HEALTH SYSTEMS DEVELOPMENT Project and intends a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding is open to all bidders from eligible source countries as defined in the *IBRD Guidelines for procurement*. Bidders from India should however, be registered with the Government of Rajasthan or other State Governments/Government of India, or State/Central Government Undertakings. **Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidder to qualify for the award of the contract.**
2. The Project Director, RHSDP invites bids for the **Repair, Renovation, Addition and Alteration works in the table**. The bidders may submit bids for any or all of the works mentioned detailed in the table.
3. Bidding documents (and additional copies) may be purchased from the office of **respective Executive Engineer, M&H from 10.03.2010 to 9.04.2010** for a non-refundable fee (three sets) as indicated in the table, in the form of cash or Demand Draft on any Schedule bank payable at Divisional Head Quarter in favour of **Executive Engineer, M&H**. Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500. The Executive Engineer, RHSDP will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
4. Bids must be accompanied by security of the amount specified for the work in the table below, drawn in favour of **Project Director, RHSDP**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
5. Bids must be delivered to office **respective Executive Engineer, M&H** on or before 15.00 hours on the specified date as mentioned in the table and will be opened on the same dates at 15.30 hours in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bid will be received and opened on the next working day at the same time and venue.
6. A pre-bid meeting will be held on **25.03.2010** for works at 11.00 AM in the office of **respective Executive Engineer, M&H**, to clarify the issues and to answer question on any matter that may be raised at that stage as stated in clause 9.2 of "Instruction to bidders" of the bidding document.
