G.S.R. 599 (E).—In exercise of the powers conferred by section 32 of the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994 (57 of 1994), the Central Government hereby makes the following further amendments to the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Rules, 1996, namely:

- 1. (1) These rules may be called the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Amendment Rules, 2017.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Rules, 1996, in rule 5, in sub rule (1), after the proviso, the following proviso shall be inserted, namely:-

"Provided further that no government institution which provides health and medical services shall be required to pay fee for registration and renewal of registration".
