The PG Diploma in Public Health Management (PGDPHM) is supported by Ministry of Health and Family Welfare under National Rural Health Mission (NRHM) being run by All India Institute of Hygiene and Public Health (AIIPH) at Kolkata, IIPH centers at Ahmedabad, Delhi, Hyderabad and Bhubaneswar, MGIMS-Wardha, NIHFV-New Delhi and JIPMER-Puducherry. PGIMER-Chandigarh, is going to start this course from this academic year. This Diploma Course is a 1 year full residential course aimed at capacity building of health functionaries, so as to bridge the gap in Public Health managerial capacity amongst health professionals in the country. The course fee for in-service candidate for the next academic year 2011-12 is Rs. 2.50 Lacs including all costs.

The proposed allocation of Seats / States is as follows:

As the seats are limited, we would expect atleast 10-15 number of nominees from each large State and suitable number from smaller States/UTs. The State Governments may like to identify GDMOs who have done only MBBS or AYUSH Doctors working in the Public Health Delivery system as there is a strong felt need to build capacity of this health force. It is also emphasized that nominated candidates may be treated as 'on duty' while pursuing this course.

I would request all the State Governments to include this training course in their respective State PIPs and budgetary provision for the same in their state PIPs 2011-12 under NRHM and nominate at least 10-15 candidates (in large states) and suitable number (in smaller states) of candidates to respective institutes. The Institutions have requested the entire amount be paid in one installment at the time of admission to the course for 2011-12. Since the admission needs to be finalized, I would request the State Governments to nominate their candidates to the respective Institutions directly. The Institutions will directly approach you on my behalf to clarify the PGDPHM Course content or for other logistic inputs. The candidates may be nominated directly to the concerned institute with intimation to the ministry.
