ORDER

In partial modification of the Department's order No F.20(PMU)/NRHM-Acct/HRD/2008/2425 dated 8.8.08 and 3.10.08, the following candidates are being allotted districtwise and CM&Hos are advised to identify institutions within the district on following priorities

- (1) 1st priority to be given if vacancy exists at Block CM&HO
- (2) 2nd priority to vacant CHC.
- (3) 3rd priority to vacant 24x7 PHC

CM&HOs are advised that relocation has been done on following conditions

1. That the candidates will have to resign from the exiting society and sign a fresh agreement on Rs 100/- non-judicial stamp paper with the institution to which they have been relocated. Incharges of the concerned institution will sign the agreement on behalf of Society.
2. The agreement will be for the balance period of contract of two years signed earlier i.e. the period of contract served in the previous district will be reduced while signing the new contract. The CM&HO of the relieving district will issue the service certificate in this regard.
3. The candidates will not be entitled for any kind of TA/DA for this relocation / transfer.
4. The candidates will not be entitled for any joining period.
5. The other Terms & Conditions of the contract shall remain the same.


