### **Eligibility:-**

- (a) Candidates must have passed 10+2 Senior Secondary examination of the Indian School certificate examination or equivalent examination or acquired qualification which is equivalent to 10+2 Examination after a period of 12 years study, the last two years of study comprising Physics, Chemistry, Biology and English.

The candidates must have passed in the subject of Physics, Chemistry, Biology & English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination as mentioned in clause (2) of regulation 4 of Graduate Medical Education 1997, Medical Council of India. In respect of candidates belonging to Scheduled Castes, Scheduled Tribes or Other Backward Classes, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination be 40% instead of 50% as above.

- (b) The candidate must complete 17 yrs of age on or before 31<sup>st</sup> December 2013.
- (c) The candidate must be medically fit, the fitness will be ascertained by The Medical Board constituted by the college.
- (d) The applicant shall furnish the declarations as detailed in the application form.

Jhalawar Hospital Medical College Society, Jhalawar issues the following guidelines for filling the NRI quota of MBBS admissions to Jhalawar Medical College for the academic session 2013-14

- (1) For providing maximum opportunity to the eligible candidates of NRI category living or studying in the country or abroad a wide publicity will be made through media well in time including the DMHS website: [rajswasthya.nic.in](http://rajswasthya.nic.in).

Application completed in all respects must reach Director (RCH) Swasthya Bhawan, Room No. 327, Tilak Marg, C-Scheme, Jaipur 302004 (Rajasthan) by 12.07.2013 (5.00 PM.) The applicants will be required to appear before the Selection Board on 17.07.2013 10.00 AM at Swasthya Bhawan, Tilak Marg, C-Scheme, Jaipur.

- (2) **Eligibility: - According to MCI Graduate Medical Education Regulations 1997 and Ordinance 272 of Rajasthan University of Health Sciences.**
