Sub : INVITATION FOR QUOTATIONS FOR SUPPLY OF GLUCOMETER, B.P APPARATUS & WEIGHING MACHINE(ADULT)

1. The Government of India has received a credit (Credit No –3867 IN) from the World Bank in various currencies towards the cost of the Rajasthan Health Systems Development Project and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for bids is issued.
2. The Project Director, RHSDP invites sealed bids from eligible bidders for supply of Equipments listed below for RHSDP-

3. **Bid Price**

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- b) All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The Prices should be quoted in Indian Rupees only.

4. Each bidder shall submit only one quotation.

5. **Validity of Quotation**

Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.

6. **Evaluation of Quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed ; and
- (b) confer to the terms and conditions, and specifications.
- (c) Past performance
- (d) EMD in form of D.D./ Bankers Cheques in favour of PD, RHSDP payable at Jaipur as per para 2
- (e) The Quotations would be evaluated together for package G24.

7. **Award of contract**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price. The successful bidder shall furnish the performance security @ 5% of the contract value in form of DD/ Banker's cheque or Bank guarantee and shall remain valid up to after 60 days completion of warranty period.

- 7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
 - 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 8. Payment shall be made immediately after delivery of the goods.
 - 9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.

GLUCOMETER

Technical Specification:

1. Glucometer should be capable of working on minimum blood sample .
2. Operable at wide range of temperature + 10 to +40⁰ C. +/-5% tolerance.
3. Must have at least 100-150 add on test memory with time and date.
4. Must be supplied as a complete unit with lancet, standard protective cover, battery, and with 200 glucose test strips with each glucometer.
5. Must conform to relevant IS/BSI/CE or any other equivalent recognized standard.

B.P. APPARATUS

Sphygmomanometer, Mercurial, Boxed, Adult, Tubular, bulb operated. Calibrated from 0 to 300mm Hg. Complete with adult Velcro closing cuffs and box with locking facility to the mercury tank and fitted with metallic hinges. The opening and closing operation shall be smooth and without any resistance.

Should be duly ISI marked for its performance and safety.

WEIGHING MACHINE ADULT

Capacity: 120 kg x 500 gm calibration easily cleanable, disinfectant resistant suitable for weighing pediatric to adult. It should be round in shape of minimum dia. 320mm or square in shape of size 320mm X 320mm & its reading dial should be easily readable from the patient height.

Zero Setting.

Should comply with relevant IS or equivalent GMP standards. The Weighing scale should have certification on each piece from Department of Weights & Measures (Legal Metrology) of the state in which the factory is situated.
