- 2. As you are awars, the National Testing Agency (NTA) is conducting NEET (UG) 2020, on behalf of the Ministry of Health & Family Welfare as a uniform entrance examination for admission to all undergraduate medical courses in all medical colleges across the country (including AHMS and JIPMER), in terms of the provisions of Section 14 of the National Medical Commission (NMC) Act, 2019. The norms and procedures for conducting NEET (UG) are regulated as per the provisions of the relevant Graduate Medical Education Regulations of MCI notified by the Ministry of Health and Family Welfare from time to a time under Indian Medical Council Act, 956.
