- ❖ The original, along with attested copies, certificate in respect of educational qualification, caste or past experience, as the case may be, shall be submitted along with joining report.
- ❖ He/she shall not take up any other assignment during the period of contractual appointment.
- ❖ This contractual appointment shall stand terminated on 25.08.2028. During the period of employment; he/she may resign by giving a notice of three months. The appointing authority is also competent to terminate his/her appointment by giving a notice of three month or salary thereof.

In case, the above terms and conditions are acceptable he/she may report for duty to the **CMHO Udaipur** before 24.08.2023 (Not more than fifteen days). After expiry of this period the appointment order shall stand cancelled.
